Procedure:

1. Combine the phase A ingredients and mix until uniform (about 1 hour).
2. Add each ingredient of phase B individually to phase A with moderate mixing and homogenize.
3. Combine phase C ingredient with fragrance and preservative as desired, then add the combination to the main vessel and homogenize.
